- Art. 1. To choose a Moderator to preside at this meeting.
- Art. 2. To elect by Australian ballot, one Selectman for a three year term. For the purposes of the above balloting, the polls will be open Friday, February 28, 2025 from 1:00 p.m. to 8:00 p.m. The remaining business to be transacted under this warrant will be taken up at 10:00 a.m. on Saturday, March 1, 2025.
- Art. 3. To see what sum of money the Town will vote to raise or appropriate for the disposal of recyclables and solid waste.

To see if the Town will authorize the Selectmen, on behalf of the Town, to sell or dispose of any real estate acquired by the Town for non-payment of taxes thereon, and execute a quitclaim deed for each such property, provided that such sale and disposal are by public means; "Except that the Municipal Officers shall use the special sale process required by 36 M.R.S. 943-C for qualifying homestead property if they choose to sell it to anyone other than the former owner(s)."
- Art. 23. To see if the Town will vote to accept prepayments of current year taxes with no interest earned.
- Art. 24. To see if the Town will vote to accept State and Federal Funds for the following categories:
 - A. Municipal Revenue Sharing
 - B. Local Road Assistance

C. State Aid to Education (including Federal pass through funds and property tax relief)

- D. Public Library State Aid per Capita
- E. Civil Emergency Funds (Emergency Management Assistance)

The Registrar of Voters will be in session from 12:45 p.m. to 8:00 p.m. on Friday, February 28, 2025 to correct any error in or change a name or address on the voting list, to accept registration of any person who becomes 18 years of age on the day of the meeting or after the close of registration prior to it, and to accept any new registrations or enrollments.

A person who is not registered as a voter may not vote at any election.
